Your Membership or subscription will run from January 1st or date of application through December 31st.

This is your official dues notice, as directed in the By-Laws of the United Alaskan Klee Kai Association, Inc. Membership dues are due and payable as of January 1st. All members whose dues remain unpaid after March 31st will be considered lapsed and automatically terminated. Returned checks do not constitute payment of dues.

Dues are as follows.

___ **Individual Membership: \$25.00/year**

Open to members 18 years of age or older. Individual members are entitled to one vote and are eligible to hold office in the association.

___ **Family/Household Membership: \$40.00/year**

Open to members of a household 18 years of age or older. Each Family/Household member is entitled to two votes but only one members may hold office at any time.

___ **Junior Membership: \$5/year**

Open to any individual who is 8-17 years of age. Juniors may convert to regular membership upon reaching their 18th birthday. Juniors shall not be entitled to vote, nor eligible to hold office, but shall be eligible for annual trophies offered by or through the association.

___ **Newsletter Subscriptions only: \$12.50/year**

Open to anyone interested in the Alaskan Klee Kai breed. Subscribers shall not be entitled to vote, nor eligible to hold office.
